## CALL FOR NOMINATION FOR MEMBERS TO THE NATIONAL COUNCIL FOR PERSONS WITH DISABILITIES 2021

### CALL FOR NOMINATION

Following the publication of Statute Law (Miscellaneous Amendment) Act, 2017 on 19<sup>th</sup> April 2017, the Ministry of Public Service, Gender, Senior Citizens Affairs and Special Programmes which has the mandate on disability hereby calls upon Organizations of/for Persons with Disabilities (OPDs) to nominate qualified persons with skills and with capacity to enable the National Council for Persons with Disabilities to deliver on its mandate to the people of Kenya.

Vacant Positions are as follows as per Statute Law (Miscellaneous Amendment) Act, 2017 of the PWDs Act, 2003;

1. Four (4) positions where members represent Organizations **OF** Persons with Disabilities) under section 4(1) (d) (i).
2. Two (2) positions where members represent Organizations **FOR** Persons with Disabilities, including parents of Persons with Mental Disabilities under section 4(1) (d) (ii).

### Nomination Guide

1. Nominees should NOT be State or Public Officer.
2. Nominees should be competent enough to carry out prescribed roles and spearhead matters of Persons with Disabilities.
3. Nominees should NOT be serving currently in other two (2) boards.
4. Gender balance should be observed.
5. Nominees should represent various categories of disabilities.
6. Rural- based organizations of/for Persons with Disabilities are encouraged to nominate.
7. Nominees should meet the requirements of Chapter Six of the Constitution of Kenya.
